Teams will be placed into the category of the oldest player on your team.

I hereby apply to participate in the New Community 3-on-3 Basketball Shootout (the "Tournament") on February 27th, 2010. I understand that participating in the Tournament will expose me to risks of injury or harm. I agree that I am responsible for my own safety. I hereby fully and forever release, discharge, and

agree not to sue New Community Church, The Fellowship of Christian Athletes and the Juvenile Diabetes Research Foundation International and other tournament organizers for any and all claims.

PRE-GAME & RULES

After check in for each pool play has been completed all players and coaches in each pool will be requested to gather for a short presentation from a representative from the Fellowship of Christian Athletes and from the Juvenile Diabetes Research Foundation.

Teams must be at their court at the scheduled game time, even if games are "running behind" for any reason (inclement weather, slow play, etc.). All games may start and be completed with any number of players (3, 2, 1). **Game time is forfeit time.**

Each team is allowed one (1) one minute time-out per game.

A coin flip before the start of the game will determine who gets the ball out-of-bounds first. The ball will change possession after each basket scored. Jump balls will be called by the referee and will go to the defense. A ball out-of-bounds will be taken at the top of the court.

A field goal is worth 1 point. A successful goal from behind a designated line is worth 2 points. Games will be played to 15 points (win by 2) or the first team to score 20 points, with a 20-minute time limit. The official time will be under the jurisdiction of the referee. The team leading at the end of the 20 minutes time limit will be declared the winner. If the game is tied after 20 minutes of play the referee will flip a coin to determine team possession. The first team to score will win the game.

All shooting fouls will be handled in the following manner:

1. when the basket is made, count the basket and possession goes to the defensive team.
2. If the basket is missed the offensive team retains possession.

The referee or Medical Personnel shall order any player who is bleeding or has blood on his/her skin, shirts, shorts or uniform to leave the game for appropriate treatment.

Games may be delayed due to unforeseen circumstances or adverse weather. Game times may be shortened, points to win a game may be reduced and/or the tournament format may be changed. A rescheduled date will be established if the tournament is cancelled due to unforeseen circumstances or adverse weather conditions.
